**TERMS AND CONDITIONS APPLICABLE FOR EOI FOR SUPPLY OF MONTHLY
MEDICINES/ACCESSORIES DURING THE YEAR 2017-18.**

1. Sealed E.O. I in prescribed Form are invited from interested registered Firms/Medicine suppliers / Medicine stores are invited for supply of medicines /accessories to Nandankanan Zoological Park for the year 2017-18 with minimum rebate of 10% of the cost of medicine.
2. The sealed quotations should be addressed to Deputy Director, Nandankanan Zoological Park, PO: Barang Dist: Khordha PIN-754 005 and superscribed "E O I for supply of monthly medicines/accessories to Nandankanan" at the top left hand corner of the envelope and to be submitted by Regd. Post/Speed post/ Courier/by hand so as to reach the office of the undersigned by 12.30 PM of 03.05.2017.
3. The sealed E.O. I will be opened at 3.30 PM on 03.05.2017 in the office of the Deputy Director, Nandankanan Zoological Park in the presence of the sub-committee headed by the Deputy Director and the E.O. I person or their authorized representatives.

E. O. I received beyond the schedule time will not be considered. Once opened, no E. O. I will be allowed to be withdrawn till finalization of the E.O. I process.
4. The E.O. I should be accompanied with the following documents.
 - a. Pass photo size photo graph.
 - a. EMD for Rs.10,000/ in shape of Demand Draft/Fixed Deposit drawn in favour of Deputy Director, Nandankanan Zoological Park on any Nationalized Bank payable at Bhubaneswar.
 - b. Copy of the certificate issued by the Drugs Controller.
 - c. Copy of the PAN Card
 - d. Copy of the Votor ID
 - e. Firm Registration.
 - f. Service Tax Clearance Certificate.
 - g. Income Tax Clearance Certificate
 - h. Sales tax clearance Certificate
 - i. Copy of the company authorization to keep the drugs/medicine and sale
 - j. Credentials (in support – Attach the copies of various contract if any)

The E. O. I without aforesaid documents shall be liable for rejection.
5. The successful E.O. I should supply the medicine at his own cost at Nandankanan.
6. The successful E.O. I should supply the medicines within 3 days of issue of supply order. In case of failure to supply the medicines within the stipulated time, the deposited EMD shall liable to be forfeited to Government and no claim what so ever shall be entertained thereafter.
7. The Firms shall be selected on the basic of the credentials/reputation subject to submission of all the required documents mentioned in item 4 above.
8. The authority reserves all right to accept or reject the E.O.I without assigning any reason thereof.
