TERMS AND CONDITION FOR THE SUPPLY OF LABORATORY CHEMICALS, GLASS & PLASTIC WARES FROM REPUTED COMPANIES/ DISTRIBUTOR/STOCKISTS / FIRMS FOR USE IN THE ZOO LABORATORY, NANDANKANAN ZOOLOGICAL PARK FOR RESEARCH & DIAGNOSTIC PURPOSE

- 1. The tenderers have to submit the rates for the supply of laboratory chemicals, glass and plastic wares for the period of one year from reputed Companies / Multi- National companies/Distributor/Stockists for the use in the Zoo Laboratory for research and diagnostic purpose. This rate should be quoted without any other condition. Taxes etc. shall be as per Govt. rules in force.
- 2. The tenderers should have a valid license to supply laboratory chemicals, glass and plastic wares. Tenderers should have minimum 3 years experience in supply of laboratory chemicals, glass and plastic wares to Central and state government research organizations.
- 3. The period for supply of chemicals, glass and plastic wares will be from **20.10.2023** to **31.03.2024**. The highest offered discount on MRP for the laboratory chemicals, glass and plastic wares should be submitted in the sealed envelope in the prescribed proforma by the latest **16.10.2023** at **5:00** PM.
- 4. The tenderer has to submit an amount of **Rs. 5,000/-** (Rupees Five thousand) only as **earnest money deposit (EMD)** in the form of a demand draft made in favour of Deputy Director, Nandankanan Zoological Park, Bhubaneswar from a Nationalized Bank/Scheduled Bank along with this tender failing which the tender will be rejected.
- 5. The successful tenderer has to submit a security deposit of **Rs. 50,000/-** (Rupees Fifty thousand only) in the form of a fixed deposit in the Nationalized Bank/Scheduled Bank pledged to Deputy Director, Nandankanan Zoological Park payable at Bhubaneswar within 7 days of award. The security deposit would be released in favour of the tenderer after the successful completion of the tender period. In case of any breach of terms and conditions, unsatisfactory performance, or other lapses, the security deposit would be forfeited to the Government. The decision of the Deputy Director, Nandankanan Zoological Park would be final and binding on this matter.
- 6. The tenderer has to supply the chemicals, glass and plastic wares to the Zoo laboratory as and when requisitioned as per the direction of Deputy Director, Nandankanan Zoological Park. No transportation charges shall be given for the same. The supply may be for more than one or two times a day as per the need/emergent situation. The indented chemicals, glass and plastic wares should be supplied to the Zoo laboratory within 3 (three) days. If the ordered chemicals take longer period to supply, it should be intimated to Deputy Director, Nandankanan Zoological Park during the above 3 days period about the delay which should not exceed 15 days.
- 7. The tenderer has to attach a copy of the annual income tax return & GST return for the last three years and good conduct certificate from the two Gazetted Officers of the Government of Odisha as well as experience certificate, voter identity card, residence proof.
- 8. The Deputy Director, Nandankanan Zoological Park may cancel the tender at any time without assigning

any reason thereof.

- 9. The Deputy Director, Nandankanan Zoological Park, Bhubaneswar at any time by notice in writing can terminate the contract without any compensation if the contractor commits any breach of the contract. Deputy Director, Nandankanan Zoological Park, Bhubaneswar reserves the right to impose a monetary penalty at his discretion on the extent of the average monthly contract value on each occasion or actual loss occurred to the Government whichever is higher.
- 10. The successful bidder shall be personally responsible for retaining and safe custody of the chemicals, glass and plastic wares requisitioned from this office until the same are handed over to the Zoo laboratory section. Any claim of loss/lost compensation etc. shall be paid by him and the Nandankanan Zoological Park will not be responsible for the above. The tenderer should have a valid licence in his name from the Government authority for the supply of laboratory chemicals, glass and plastic wares and copy of such licence is to be enclosed
- 11. The contractor has to execute an agreement in the non-judicial stamp paper of **Rs.100/-** per form to be furnished by Nandankanan Zoological Park in India.
- 12. All powers in awarding contract in relaxation of any eligibility criteria lie with the Deputy Director, Nandankanan Zoological Park.
- 13. The Deputy Director Nandankanan Zoological Park shall have all the right to reject / accept any tender without assigning any reason.
- 14. Technical bid and financial bid should be kept in separate envelopes duly sealed and both bids should be kept in one envelope duly sealed and addressed to the Deputy Director, Nandankanan Zoological Park, Bhubaneswar.
- 15. Any clause of the tender can be cancelled / modified / altered during the course of the tender / period of work at the discretion of the Deputy Director, Nandankanan Zoological Park and the tenderer shall have to accept the altered or modified condition.

PENALTY

If the contractor commits any breach of this contract, he shall be liable to be fined upto an amount not exceeding 1/4th of the contract value for every act of default or negligence. On demand, the amount should be deposited within 10 days. The Deputy Director, Nandankanan Zoological Park reserves the right to cancel the contract within 15 days of the notice period.

PEROD OF CONTRACT

- A. The contract will be for a period of from 20.10.2023 to 31.03.2024.
- B. Under no circumstances the contractor will be allowed to leave before the completion of contract period.
- C. In the event of contractor leaving before completion of contract period, the security deposit will be forfeited.
- D. The validity period of the present tender is **20.10.2023 to 31.03.2024**, but it can be extended on the same approved rates at the discretion of Deputy Director, Nandankanan Zoological Park on the satisfactory

performance of the contractor.

START OF THE OPERATION

- I. The successful tenderer shall have to start the supply of laboratory chemicals, glass and plastic wares as per the requisition of Deputy Director, Nandankanan Zoological Park from **20.10.2023** positively.
- II. If the same rate is offered by more than one tenderer then the Deputy Director, Nandankanan Zoological Park immediately after opening such tenders will permit those tenders who are present and who have offered one and the same rate to increase their offer and the highest offer so increased will be considered for acceptance, or otherwise in case there is a refusal to increase the offer or in the absence of respective tenders, the tenders which are to be considered for acceptance will be decided by drawing lots.
- III. The act of the submission of the tender shall be deemed to be as unreserved acceptance of all condition herein contained.
- IV. The amount of loss, penalty, compensation, interest etc, if not paid within a period of 15 days from the date of demand, shall be liable for forfeiture of security.

LOSS TO NKZP

In the event of any loss to the Nandankanan Zoological Park on the account of any act of commission or omission by the contractor's employees, the contractor shall make good the loss suffered by Nandankanan Zoological Park either by replacement or by payment of adequate compensation as decided by the Deputy Director, Nandankanan Zoological Park.

JURISDICTION OF COURTS

- I. All disputes shall be subject to the jurisdiction of courts in the Bhubaneswar.
- II. The Deputy Director, Nandankanan Zoological Park reserves the right to accept or reject any tender without assigning any reason thereof.

EARNEST MONEY DEPOSIT (E.M.D)

- I. All bidders shall have to deposit earnest money of **Rs. 5,000/- (Rupees Five thousand) only** in the form of a Demand Draft payable in the name of Deputy Director, Nandankanan Zoological Park Bhubaneswar from a Nationalized/scheduled bank along with their Bid application inside the envelope.
- II. Demand Draft/Pay Order/Banker's Cheque issued earlier than the date of advertisement inviting bids for supply of laboratory chemicals, glass and plastic wares to the Nandankanan Zoological Park, will not be accepted.
- III. Earnest money shall be refundable to the unsuccessful bidders within one month of the award of allotment letter. The bidders have no right to demand interest on the Earnest Money. However, the successful bidder's earnest money shall be returned only once the successful bidder has deposited the security deposit.
- IV. However, in case where the bidder withdraws or modifies the bid during the 100 days validity of the bid or it has come to the knowledge that bidder has used fraudulent practices for this bid, the earnest money shall be forfeited.
- V. Tender received without EMD will be rejected summarily.

TERMINATION OF THE CONTRACT

- a. The Deputy Director, Nandankanan Zoological Park can terminate the contract at any time after serving two weeks' notice to the contractor for breach of any condition of the contractor if during the period of the contract, the performance is not found satisfactory.
- b. The decision of The Deputy Director, Nandankanan Zoological Park shall be final and binding on the contractor in this regard.
- c. Failure by the contractor to comply with any statutory requirements during the period of the contract shall result in the termination of the contract and subsequent disqualification for participation in any future tender in the Nandankanan Zoological Park.
- d. The contractor will not be allowed to leave the contract before the contract period (20.10.2023 to 31.03.2024) failing which the contract will be terminated and the security deposite will be forfeited. Failure by the contractor to comply with any statutory requirements and terms of the agreement during the period of contract shall result in termination of the contract forthwith and subsequent disqualification of the contractor for participation in any future tender at the Nandankanan Zoological Park. The security deposit will also be forfeited.

RENEWAL OF THE CONTRACT

- i. The period of the contract will be from 20.10.2023 to 31.03.2024.
- ii. The contract can be extended beyond 31.03.2024 subject to satisfactory performance as per the discretion of Deputy Director, Nandankanan Zoological Park.
- iii. The Deputy Director, Nandankanan Zoological Park reserves the right to curtail/extend the period as per the prevailing circumstances.
