- 1. Sealed Tender in prescribed Forms are invited by the Deputy Director, Nandankanan Zoological Park, Barang from the interested individuals/ Firms/ agencies/ companies for Construction of Moat / Hexagon Visitors View Point/ Pentagon Visitors View Point / Feeding Cell and Keepers' Room Including Electrification And Water Supply / Kraal-02 Nos. in the Primate Enclosure inside Nandankanan during, 2021-22.
- 2. Form of Tender: The Tender form will consist of two parts, (i) Form-A (Technical) and (ii) Form-B (Financial). Form A (Technical) & Form B (Financial) are to be kept in two separate sealed covers over which it has to be written clearly "Form-A" / "Form-B" as the case may be and both the covers should be kept in a single sealed cover super-scribing "Tender for Construction of Moat / Hexagon Visitors View Point/ Pentagon Visitors View Point / Feeding Cell and Keepers' Room Including Electrification And Water Supply / Kraal-02 Nos. in the Primate Enclosure inside Nandankanan during, 2021-22" and the name of the tenderer or else tender shall not be considered. The tender shall apply for single or multiple item of work mentioned in the financial bid.
- 3. Tender form can be downloaded from the website of Nandankanan Zoological Park www.nandankanan.org and submitted with a Bank Draft of Rs.4,720/- (Rupees four thousand seven hundred twenty) only inclusive of 18% GST drawn in favour of the Deputy Director, Nandankanan Zoological Park in any nationalized Bank payable at Bhubaneswar towards cost of tender papers. The cost of tender papers is not refundable under any circumstances.
- 4. The tender should be addressed to the Deputy Director, Nandankanan Zoological Park, PO: Barang Dist: Khordha PIN-754005 and dropped in tender box / submitted by registered post so as to reach the office of the undersigned by 12.00 noon of 28.02.2022.

- 5. The sealed tender will be opened at 2.30 PM on 28.02.2022 in the Conference Hall of Nandankanan Zoological Park in presence of the tender opening committee under chairmanship of Deputy Director, Nandankanan Zoological Park in presence of the tenderer or their authorized representatives.
- 6. Tender received beyond the schedule date & time will not be considered. Once opened, no tenderer will be allowed to withdraw till finalization of the tender process.
- 7. The successful tenderer should follow all the prevailing labour rules & regulations by the Govt. of Odisha / Govt. of India.
- 8. The tender should be accompanied with the following documents:
 - A. Passport size photograph of the tenderer.
 - B. EMD in shape of Demand Draft drawn in favour of Deputy Director, Nandankanan Zoological Park on any Nationalized Bank payable at Bhubaneswar as specified in Form "B" for individual items of work.
 - C. Self attested copies of following documents must be attached along with application:
 - I. Copy of the PAN Card
 - II. Copy of the Aadhar Card
 - III. Income Tax Clearance Certificate.
 - IV. Copy of GST Registration Certificate
 - D. Valid labour license certificate under contract labour (Regulation and abolition) Act, 1970 / Contractor license "C" or above.
 - E. Proof of being a registered man-power service provider in the related field with Valid Registration Certificate of the firm / Society / entrepreneur / Company.
- 9. Preferences will be given for credibility and experience certificate issued from any related concerned Authority / Employer of a Govt. / ULB / PSU of repute with a minimum period of **02** (Two) years for the works of similar nature.
- 10. The tender without related documents shall be liable for rejection.
- 11. The tenderer / agency will **quote the rate** for Construction of Moat / Hexagon Visitors View Point / Pentagon Visitors View Point / Feeding Cell and Keepers' Room Including Electrification and Water Supply / Kraal-02 Nos. in the Primate Enclosure inside Nandankanan during, 2021-22 as per the scope of work mentioned in Para No.35. The rate to be quoted inclusive of all taxes & other

- incidental charges and shall be both in figures & words as per the format specified in Financial Bid (Form- "B").
- 12. After finalization of the tenderer, the successful tenderer / Agency shall be required to be made an agreement with the Deputy Director. Nandankanan Zoological Park.
- 13. The term 'Deputy Director' wherever mentioned in the document of Agreement shall mean the "Nandankanan Biological Park" authority. The term "Agency" wherever mentioned in the document shall mean the party selected for award of the contract. The term "Contract" means the agreement between the "Deputy Director" and "Agency" which would be signed at the time of awards the work assignment.
- 14. The tenderer has to submit EMD separately for each item of work.

15. The EMD shall subject to forfeiture in the following cases:

- a. In case the successful tenderer withdraws from the tender after opening of his bid.
- b. In case the successful tenderer does not come forward to sign the agreement within the stipulated time period by the Deputy Director.
- 16. The EMD of successful tenderer shall be only returned after successfully completion of the tender process.
- 17. The successful tenderer or his authorized agent for the work has to in contact with the Range Officer, Sanctuary Management for completion of work in time.
- 18. The required materials will be supplied departmentally by the Range Officer, Sanctuary Management Nandankanan Zoological Park.
- 19. The successful tenderer has to submit security deposit in the form of Bank Draft drawn in favour of Deputy Director, Nandankanan Zoological Park on any Nationalized Bank payable at Bhubaneswar which is 10% of the bid value on or before the execution of agreement for individual item of work. The successful tenderer in the event of any unwanted occurrence or breach of contract the compensation as assessed by the undersigned shall be recovered from his security deposit.

- 20. During the period of contract the successful tenderer shall provide uninterrupted service with diligently, honestly and to the satisfaction of the Deputy Director / authorities of Nandankanan Biological Park.
- 21. The successful tenderer shall be entirely responsible regarding genuineness and identity of the workers engaged by him and should provide ID proof during Construction of each tender item of primate enclosure inside Nandankanan Zoological Park.
- 22. The Construction of each tender item of primate enclosure inside Nandankanan Zoological Park should be completed on or before **25.03.2022** positively. The completion of the work as per agreement should be jointly signed and handed over to the Range Officer, Sanctuary Management.
- 23. If the Successful tenderer fails to perform his Construction of each tender of work inside Nandankanan Zoological Park under scope of work at para No.35 on or before 25.03.2022, the proportionate payment for the work shall not be considered / forfeiture of the Security Deposit as per recommendation of Range Officer, Sanctuary Management and Asst. Conservation of Forest, Sanctuary Management for deviation of quality / quantity of the works.
- 24. The Security Deposit will be refunded after two months of completion of work.
- 25. The successful tenderer shall pay all taxes to the Govt. in accordance with the existing Acts, Rules, notification and regulations. T.D.S will be deducted as per prevailing rules.
- 26. It is not binding on the part of the authority to accept the lowest tenderer and Deputy Director, Nandankanan Zoological Park reserves all the rights to reject any or all the tenderers without assigning any reason thereof.
- 27. An undertaking from the tenderer indicating that he has not been black listed by any government department or any organization in India for participating in EOI previously.
- 28. The duly filled technical bid along with supporting documents must be submitted in hard copy in time.

- 29. The original bid document dully signed and stamped on each page as a token of acceptance of terms & conditions of the tender document.
- 30. In case any dispute arising between the Deputy Director and the contractor as the matter arising under this contract such dispute shall be referred to the Director of Nandankanan Biological Park, Bhubaneswar within one week from the date of dispatch of the order by registered post acknowledgement due and his decision thereon shall be final.
- 31. The Deputy Director, Nandankanan Zoological Park has the right to annul, add, and modify any of the terms & conditions above without any notice in the interest of public.
- 32. Canvassing in any other form relating to the bidder is strictly prohibited and the bid submitted by the bidder who resorts to canvassing will be liable for rejection. The bids which do not fulfill any or all of the conditions or incomplete in any respect and incorporating additional conditions other than the conditions as mentioned herein are liable for rejection.
- 33. All Appeals shall be made to the Director of Nandankanan Biological Park, Bhubaneswar whose decision thereon shall be final.
- 34. All disputes those may arise in future shall be subject to the jurisdiction of the SDJM, Bhubaneswar only.
