### NOTICE INVITING APPLICATION FOR ENGAGEMENT OF VETERINARY OFFICER, LIVESTOCK ASSISTANT & LIVESTOCK ATTENDANTS IN MOBILE VETERINARY UNIT FOR WILDLIFE CARE & DISEASE CONTROL SERVICE, NANDANKANAN ZOOLOGICAL PARK

Applications are invited for engagement of **one Veterinary Officer, one Livestock Assistant and two Livestock Attendants for Mobile Veterinary Unit for Wildlife Care & Disease Control Service at Nandankanan Zoological Park**. The above engagement will be purely temporary and will be terminated at any time without any notice by Deputy Director, Nandankanan. The initial engagement will be for two years subjects to satisfactory performance at the end of first year. Further continuance beyond two years may also be considered on case to case basis.

#### Essential Qualification:

Position	Number	Qualification	Remarks
Veterinary Officer	One	B.V.Sc. & A.H.	Fresh Veterinarian/Retired Veterinarian will be engaged. People with experience in wildlife field including Tranquilization of wild animals shall be given preference.
Livestock Assistant	One	+2 Science with vocational training/Trained Livestock Inspectors	Retired Para Vets. /Educated Unemployed youth with desired qualification having vocational training on animal husbandry will be engaged. People with experience in wildlife field shall be given preference.
Livestock Attendants	Two	10 <sup>th</sup> Pass	Retired attendants/ Peons of Animal Husbandry Department and Forest Department shall be engaged.

## **ROLES & RESPONSIBILITIES OF PERSONNEL ENGAGED IN MOBILE VETERINARY UNIT:**

### **VETERINARY OFFICER IN-CHARGE OF THE MVU:**

- As a team manager he/she shall bear overall responsibility for the effective functioning of the MVUs.
- The other support staff of the MVU would work under his guidance and supervision.
- He /She shall be collectively responsible for the healthcare manage and disease control of wild animals in the concerned forest division.
- He/ She refer cases to the local Block Veterinary Dispensary/ Sub-divisional Veterinary Dispensary/ District Veterinary Dispensary for further treatment.
- He/ She take immediate and appropriate action during outbreaks and inform local Veterinarian.
- He/ She shall work in coordination with the local staff of Animal Husbandry Department & local PRI authorities for control of disease outbreaks and management during natural calamities.
- Date wise performance details shall be maintained in a register under given heads.
  - Name of the livestock owner contacted.
  - Particulars of examination conducted/ observation made.
  - Cross checking of vaccination status of domestic animals in forest areas.
  - Awareness programme conducted
  - Sample collected and dispatched to any referral laboratory.
  - Logbook of the vehicle
  - Any particular matter worth reporting
- Any other work to be assign as per the requirement from time to time.

### **LIVESTOCK ASSISTANT:**

- He/ She will be assisting the Veterinary Doctor, in-charge of MVU in all above said healthcare and disease control services in animals.
- He/ She should have a good coordination with local Livestock Inspector/ other workers of Animal Husbandry Department.
- He/ She will take care of all the medicine & instrument stocks.
- He/ She shall maintain all registers and records.

### **LIVESTOCK ATTENDANT**

- He/ She will assist the Veterinary Officer during supportive & curative treatment of injured sick wild animals.
- He/ She will help him transportation of required equipments from the vehicle to the site of treatment.
- He/ She will work under the direct control of Veterinary Officer of MVU as per the instructions and requirement of the situation from time to time.



### **Other Conditions:**

- 1. Duration:** The initial engagement will be for two years subjects to satisfactory performance at the end of first year. Further continuance beyond two years may also be considered on case to case basis.
- 2. Leave:** 5 days in a month will be treated as weekly off day for MVU staff. But in case of emergency they have to perform their duties as per the requirement.
- 3. Remuneration:**

Remuneration for various posts have been fixed as follows

**Veterinary Officer- Rs. 65,000/-** per month

**Livestock Assistant- Rs. 25,000/-** per month

**Livestock Attendant- Rs. 15,000/-** per month

Revision/enhancement of the remuneration shall be at the discretion of PCCF (WL) & CWLW, Odisha.
