- 1. Nandankanan Zoological Park hereby issues this notice for the attention of all potential bidders that the last date of submission of bids (hard copy) has been extended up to 5.00PM of 16.09.2023
- 2. The date of opening of Technical Bids, Technical Presentation and opening of Financial proposal shall be on 18.09.2023 at 11.00 AM.
- Section-2 (Instruction to bidders), Para-1 (Pre-qualification criteria), Sl. No. 4 has been corrected and replaced as follows:

"The Consultant/Consultancy firm must have minimum average annual receipts of Rs.0.40 Crores from professional fees/Consultancy services during the last 5 financial years. Certificate from Charted Accountants or Income Tax Return in support of same must be submitted with the proposal."

4. Section-2 (Instruction to bidders), Para -7 in Technical Evaluation (2nd Stage) 1.b. has been corrected and replaced as follows:

The bidder should have a minimum annual average turnover of Rs.0.40 Cores in the last 5 financial years.

5. Section-2 (Instruction to bidders), Para-9 Performance Bank Guarantee (PBG) has been corrected and replaced as follows:

"Within 7 days of notifying the acceptance of a proposal for award of contract, Selected Bidder shall have to furnish a Performance Bank Guarantee amounting to Rs.5.00 Lakh from a scheduled commercial bank situated in Bhubaneswar in favor of "Deputy Director, Nandankanan Zoological Park" as per the format at Annexure-II, for a period of three months beyond the entire contract period (calculated from the date of effectiveness of the contract) as its commitment to perform services under the contract. However later on after the preparation of DPR the amount of performance bank guarantee shall be calculated again which shall be equal to 10% of the consultancy fee calculated on the basis of DPR cost as prepared by the selected bidder.
