TENDER CALL NOTICE

Nandankanan Zoological Park, Bhubaneswar invites sealed tender from OEM, authorized registered dealers, reputed and experienced suppliers/manufacturers for the procurement of one Hydra. The details and specifications of the equipment are as follows:

Specifications and Requirements:

1. Hydra

Lifting capacity: Minimum 15 tons

Boom Height: Minimum 19 meters

Engine power: Minimum 40 HP

Fuel type: Diesel

Hydraulic system: High-efficiency hydraulic pump with multiple control valves

Rotation: 50-degree rotation capability

- Safety features: Overload protection, emergency/parking stop system, operator safety cabin
- Additional features: Adjustable boom, Overload Buzzer, advanced control system, ergonomic operator seat
- Quantity: 1

General Terms and Conditions:

- 1. The bidder must be a reputed manufacturer/authorized dealer with a proven track record in supplying similar equipment. Relevant certifications and proof of past supplies must be enclosed. The supplier/manufacturer shall have a valid company registration certificate or authorised dealer certificate to participate in the tendering.
- 2. The supplier/manufacturer shall have a valid OGST registration to participate in the tendering.

- 3. The supplier/manufacturer shall have a valid PAN to participate in the tendering.
- Sealed tender must be submitted to the undersigned on or before dt.23.10.2024 during office hours.
- 5. Tender/Bids must remain valid for a minimum period of 90 days from the last date of submission.
- The price quoted should be inclusive of all taxes, duties, insurance, and transportation charges up to Nandankanan Zoological Park, Bhubaneswar.
- 7. The equipment should carry a minimum warranty period of 1 years from the date of installation. (The warranty should cover all parts and labour)
- 8. The equipment should be delivered within 7 days from the date of the purchase order.
- 9. Payment will be made within 30 days of successful delivery and installation of the equipment, subject to inspection and acceptance.
- 10. The equipment will be subject to inspection upon delivery. Any defects found must be rectified at the supplier's expense. A final acceptance test will be conducted before the final payment.
- 11. The supplier must provide comprehensive training to the park's operators and maintenance staff at no additional cost.
- 12. The supplier must ensure availability of after-sales service and spare parts for a minimum of 5 years. Service response time should be within 48 hours.
- 13. Delay in delivery will attract a penalty of 1% of the total contract value per week, subject to a maximum of 10%.
- 14. The last date for submission of tender is Dt.23.10.2024 by 05.00 P.M
- 15. Opening of the bid is Dt.24.10.2024 04.00 P.M. Late submissions will not be considered.
- 16. Price should be quoted in Indian Rupees (INR).
- 17. Any delay in delivery may result in penalties as per the terms agreed upon in the purchase order.
- 18. In case of non-compliance with the specifications, delayed delivery, or failure to deliver the required quantity, penalties will be imposed as per the terms agreed upon in the purchase order.
- 19. The tender should be valid for a minimum period of 90 days from the last date of submission.

- 20. In case of any unforeseen circumstances beyond the control of either party, such as natural disasters, strikes, or other acts of God, affecting the execution of the contract, both parties will mutually discuss and agree upon the next course of action.
- 21. The undersigned reserves the right to accept or reject any or all tender without assigning any reason thereof and incomplete or conditional tender will be summarily rejected.
