Short-Tender Call Notice

Sealed quotations / tenders are invited from interested reputed firm, OEM, authorized registered dealers for SUPPLYING, INSTALLATION & COMMISSIONING OF SUPPORTING STAFF CABIN 30'X10'X9.6" & ALLIED FITTINGS for Nandankanan zoological park which shall conform to the Technical specification, Terms and Conditions as follows:

1. The service provider shall have a valid company registration certificate or authorised dealer certificate to participate in the tendering
2. The service provider shall have a valid OGST registration to participate in the tendering.
3. The service provider shall have a valid PAN to participate in the tendering.
4. The tender form will consist of two parts, (i) Form-A (Technical) and (ii) Form-B (Financial). Form A (Technical) & Form B (Financial) are to be kept in two different sealed covers over which it has to be written clearly "Form-A" / "Form-B" respectively. Both covers should be kept in a large cover super scribing "SUPPLYING, INSTALLATION & COMMISSIONING OF SUPPORTING STAFF CABIN 30'X10' & ALLIED CABIN 30' x 10' x 9.6" , and the name of the tenderer. Otherwise, the bid of tenderer will not be considered. The tender should be sealed and complete in all respect.
5. The Application form of quotation/tender containing General Bid Information & Terms and conditions for SUPPLYING, INSTALLATION & COMMISSIONING OF SUPPORTING STAFF CABIN 30'X10'X9.6" & ALLIED FITTINGS for Nandankanan zoological park will be available with Office of the Deputy Director Nandankanan zoological park, Bhubaneswar, Odisha pin-754005 or can be downloaded from Nandankanan official website www.nandankanan.org from dt.27.07.2024 11 A.M to dt.01/08/2024 by 12.00 PM. The application form downloaded from Website should be furnished with a account payee Demand Draft drawn in favour of the Deputy Director Nandankanan zoological park Payable at Bhubaneswar for an amount Rs.1180/- (Rupees One thousand one hundred eighty) only towards the cost of bid document.
6. The Tender completed in all should reach the Office of Deputy Director Nandankanan zoological park, Bhubaneswar, Odisha on or before Dt.01/08/2024 by 12.00 PM and shall be opened on Dt.01/08/2024 03.00 PM at conference hall, O/o the Deputy Director, Nandankanan Zoological Park, Baranga, Bhubaneswar in the presence of the bidders or their authorized representatives.
7. Tenders received beyond the scheduled date & time shall not be opened and considered to be rejected.
8. Once opened, no tenderer will be allowed to withdraw from tender process till its finalization.
9. Conditional tenders are not accepted and liable for rejection.
10. The undersigned reserves the right to cancel the notice & all quotations without assigning any reason thereof.

General Terms & Condition

The following terms and conditions must be fulfilled by the successfully bidder for supplying, installation & commissioning of heavy furnished porta cabin.

1. All the parts, Unloading & labours cost should be incurred by the bidder during installation.
2. The after sales terms and conditions will be strictly enforced and those bidders who are willing to support the Tender Inviting Authority in its Endeavour to provide trouble free operation/performance of the equipment for the prescribed period need only participate in the bid.
3. No advance payments towards cost of equipment will be made to the bidder.
4. The Toll charges or any other charges if any will be borne by the bidder.
5. The rate offered should be inclusive of all charges and delivery at Nandankanan Zoological Park (Per-unit cost of the items / materials / goods should be quoted inclusive of all taxes (GST etc.) as applicable).
6. The quotations may be accepted in part or whole.
7. If the contractor or his representative, through any of his activities when supplying the articles in the zoo is found to be violating any of the norms/sections of the Wildlife Protection Act,1972 (amended till date), the contract may be immediately cancelled without any notice and suitable action will be initiated as per the applicable laws and rules.
8. No tender will be considered unless and until all the documents are properly signed.
9. Applicable taxes (TDS) as per prevailing rate & rules would be deducted from the bill of the Suppliers.
- 10.If the tenders are submitted by a partnership firm, it must be signed separately by each member thereof, or in the event of the absence of any partner it must be signed on a company the quotations should be executed in the manner laid down in the said company's articles of association. The signature on the tender id document should be deemed to be authorized signatures.
- 11.The quality of all the items should be as per technical specifications given in this tender documents. The specifications may be changed by the Nandankanan zoological park administration based on the requirement or any expert. Changes in the specifications if any will be communicated to the Contractor in advance. The contractor will not claim any compensation for any loss due to change in specification of any item at any point of time.
- 12.There will be a performance security deposit amounting to the 3% of total value of the quoted value excluding taxes, which shall be submitted by the successful bidder to the Tender Inviting Authority within 7 days from the date of issuance of Contract / Purchase order. The same will be released only after completion of warranty period.
- 13.Payment will be released only after successful installation.
- 14.Canvassing in any form whether direct or implied will be disqualification.
