**TERMS AND CONDITIONS OF QUOTATION CALL NOTICE FOR SUPPLY OF  
FABRICATION MATERIALS AND OTHERS TO NANDANKANAN BIOLOGICAL PARK**

1. Sealed Quotation in prescribed Forms is invited by the Deputy Director, Nandankanan Zoological Park, Barang from interested Authorized Dealer / Firms/ agencies/ companies/ for supply of Fabrication Materials and Others to Nandankanan Biological Park for the year 2021-22.
2. Form of Quotation: The Quotation form will consist of two parts, (i) Form-A (Technical) and (ii) Form-B (Financial). Form A (Technical) & Form B (Financial) are to be kept in two separate sealed covers over which it has to be written clearly "Form-A" / "Form-B" as the case may be and both the covers should be kept in a single sealed cover super-scribing "Quotation for supply of Fabrication Materials and Others to Nandankanan Biological Park" and the name of the Bidder or else Quotation shall not be considered. The Quotation should be sealed and complete in all respect.
3. The quotation along with terms & conditions shall be available in the website of Nandankanan Zoological Park ([www.nandankanan.org](http://www.nandankanan.org)).
4. The quotation should be addressed to the Deputy Director, Nandankanan Zoological Park, PO: Barang Dist: Khordha PIN-754005 and dropped in quotation box / submitted by registered post so as to reach the office of the undersigned by 12.00 noon of 28.02.2022.
5. The sealed quotation will be opened at 04.30 PM on 28.02.2022 in the Conference Hall / Office Chamber of Dy. Director, Nandankanan Zoological Park in the presence of the quotation opening committee under chairmanship of Deputy Director, Nandankanan Zoological Park in presence of the Bidder or their authorized representatives.
6. Quotation received beyond the schedule date & time will not be considered. Once opened, no Bidder will be allowed to be withdrawn till finalization of the tender process.



7. The quotation should be accompanied with the following documents:
- A. Passport sized photograph of the bidder.
  - B. EMD for Rs.**20,000/-** in shape of Demand Draft drawn in favour of Deputy Director, Nandankanan Zoological Park on any Nationalized Bank payable at Bhubaneswar.
  - C. The original bid document dully signed and stamped on each page as a token of acceptance of terms & conditions of the bid document.
  - D. Self attested copies of following documents must be attached along with application:
    - I. Copy of the PAN Card
    - II. Copy of the Aadhar Card
    - III. Firm Registration (for Agencies/ Companies).
    - IV. Income Tax Clearance Certificate.
    - V. Copy of GST Registration Certificate (if any).
    - VI. Dealership certificate in case of authorized dealer.
    - VII. Copy of MSME certificate if claimed for exemption of EMD
8. The quotation without aforesaid documents shall be liable for rejection.
9. The successful Bidder should supply the Fabrication Materials and Others (as per requirement) at his own cost to State Botanical Garden / Nandankanan Zoological Park.
10. The payment towards supply of quality Fabrication Materials and others shall be made by the requisite authorities of Nandankanan Biological Park.
11. The bid for the supply of Fabrication Materials without the authorized dealer / retailer certificate will be subjected for rejection of the Bid.
12. The successful Bidder should supply the Fabrication Materials and Others to Nandankanan Biological Park (as per requirement) within 07 (Seven) days of issue of supply order by the authorities of Nandankanan Biological Park. In case of failure to supply the materials within the stipulated time, the deposited EMD shall liable to be forfeited to Government and no claim what so ever shall be entertained thereafter. Supply order will be given in phase as per requirement.
13. The EMD of successful bidder shall be only returned after successfully operation of contract period.
14. The bidders are requested to quote their price in kilogram / square meter / square feet / number / liter / Bundle inclusive of all taxes/royalty and delivery site at State Botanical Garden / Nandankanan Zoological Park. No additional amount will be paid to the successful bidder except the approved price.

15. The successful bidder is liable for payment of TDS or TCS as applicable, at the prevailing rates. TDS or TCS will be deducted from the successful bidder at the prevailing rates.
16. The authority reserves all right to accept or reject the quotation without assigning any reason thereof.
17. A letter from the Bidder indicating that they have not been black listed by any government department or any organization in India from sale and participating in quotation previously.
18. The duly filled technical bid along with supporting documents must be submitted in hard copy.
19. In case any dispute arising between the Deputy Director and the bidder as the matter arising under this contract such dispute shall be referred to the Director of Nandankanan Biological Park, Bhubaneswar within two weeks from the date of dispatch of the order by registered post acknowledgement due and his decision thereon shall be final.
20. The Deputy Director, Nandankanan Zoological Park has the right to annul, add, modify any of the conditions above without any notice and they shall be binding on the supplier.
21. All Appeals shall be made to the Director of Nandankanan Biological Park, Bhubaneswar whose decision thereon shall be final.
22. All disputes those may arise in future shall be subject to the jurisdiction of the SDJM, Bhubaneswar only.
