Queries regarding Operation of Bus Service to Safari in the Conference Hall of Office of the Deputy Director, Nandankanan Zoological Park.

Sl No.	Name	Query	Clarification
1	Sri Prasant Kumar Routray	Separate Battery Operated Vehicle for Safari Service. Whether shuttle Battery Operated Vehicle Service is free or paid. Number of Battery Operated Vehicle increase from 2-4 above.	It is clarified that then existing Battery Operated Vehicle operator (licencee) will only be allowed to operate the shuttle service (from Fountain square to Safari Bus stand)at the rate fixed jointly by the licencee and Deputy Director, Nandankanan. Only in the case when Battery Operated Vehicle Service is being operated by Nandankanan itself and licencee for Battery Operated Services not available in the park, the shuttle service will be run by Nandankanan. The number of Battery Operated Vehicle for shuttle service more than 4 will be only allowed after due assignment.
2	Sri Prasant Pradhan	No more Booking counter for Safari service.	In the condition No.23 of the tender document, the successful tenderer shall not sell ticket for Safari service at any other place within Zoo premises other than the ident booking counter in new Safari stand

During the discussion on pre bid query on EPF issue it is clarified that at the time of signing the agreement the successful tenderer in addition to document required as per Clause No.15 of tender document shall submit the EPF registration number of self or agency supply the man power to the bidder for the operation of Bus Services to Safaris of Nandankanan. The corrigendum regarding this shall be published.


Sri Manoj Kumar Pahadsingh told that the terms & conditions for Safari service displayed in website is perfect and suitable for visitors.


After discussion and clarification given by the Chairperson the meeting ended with vote of thanks to the chair.
